- **With our Provider Network** to ensure high quality, accessible, evidenced-based services to met our community needs.

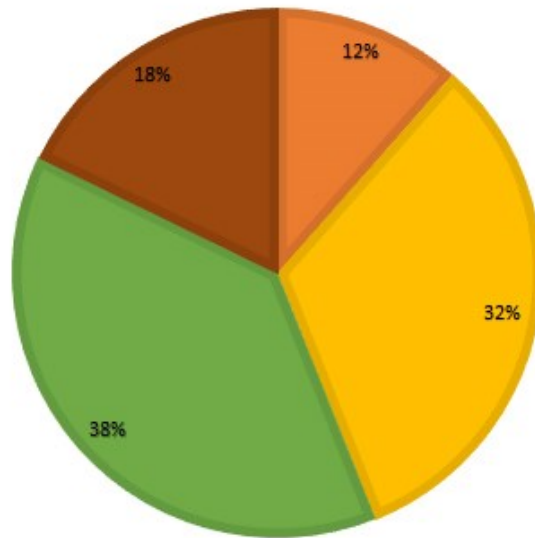
Culture of Quality (COQ)

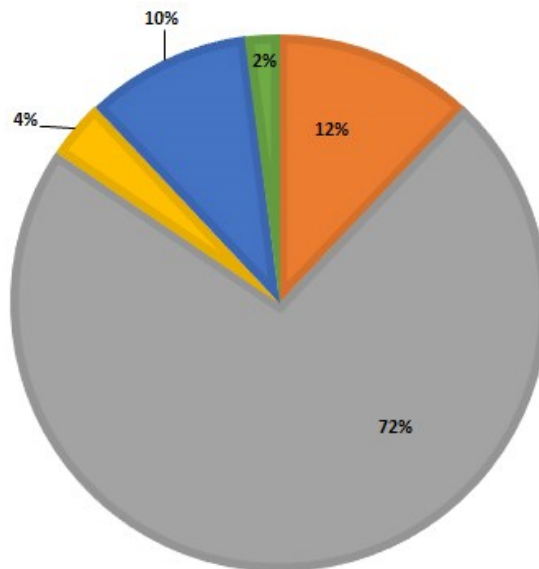

New Services FY 19

21st Century CURES Law- Funds were used for a collaborative project with the Common Pleas Court, Sheriff's Department, Pathways Counseling Center, and ADAMHS Board to support individuals that have been involved with opiates or prescription drugs. The money will support increased local community treatment including drug testing, MAT (Medically Assisted Treatment), and telemedicine services in the jail. Starting individuals on treatment at an earlier stage and connecting them to resources is the goal of the program.

Medication Assisted Treatment (MAT)- Combines behavioral therapy and medications to treat substance use disorders.

Telepsychiatry- Video-based telepsychiatry helps meet patients needs by improving access to behavioral healthcare, primarily specialized care in the are of child psychiatry.

In-School Consultation and Counseling- Is offered to all Putnam County schools. A clinician will access the student referred by the school to determine services based on need. If a student needs further services a referral is made to provide assessment of those needs.
